

# MSRT Scientific Display Rules



## I. Awards

*First Place: \$250.00 (Plus 1 yr. membership to MSRT)*

*Second Place: \$125.00*

*Third Place: \$ 75.00*

## II. Eligibility

1. Applicants must be an active, associate or student member in good standing with the MSRT
2. A copy of current membership card must accompany the application for each name on the application. Membership may be applied for at the time of the application. **If MSRT card/verification is not submitted with the application results in disqualification of the submission.**
3. Multiple co-displays is acceptable, however, only one prize will be awarded for each place.
4. Multiple Displays may be entered , but you will only be eligible to win one prize
5. **Students may not submit an entry with the same topic content to both the display and the essay competition. Submitting an entry to both competitions with the same content will result in disqualification of both submissions.**
6. **All entrants *must be registered for at least one (1) full day of the annual meeting to be eligible for a prize.***

## III. Application Procedure

**Applications (see page 3) must be received via email by the scientific display chairperson no later than, midnight, September 1<sup>st</sup> of each year. Late applications will not be accepted.**

## IV. Preparation of Display

1. Application(s) shall be submitted in the name(s) of the displayer(s).
2. Displays **WILL NOT** show any image or marking that could identify the patient/subject, institution, department, and school or display author. Any such image or marking will disqualify the entry.
3. Subject matter will be pertinent to the Radiological Sciences.
4. The entire display must be contained within the allotted space.
5. Illuminations will not be provided. Displayers are responsible for illuminators.
6. Displays must be the work of the displayer(s).
7. Any quotes or reproduced reference material must be properly cited by footnotes.
8. Title on the display must match the title submitted on the application.

## V. Installation and Dismantling

1. Display space will be assigned by the Scientific Display Committee.
2. Displays that do not meet the published criteria will not be eligible for competition judging.
3. Specific set-up and tear-down times will be forwarded to applicant via email from Scientific Display Chairperson.
4. Each displayer will be responsible for their display.
5. If a displayer is unable to install and/or dismantle their display, they may designate

- another to do so. Notification of such designation must be made in writing to the Scientific Display Chairperson prior to assigned day of installation/dismantling.
6. Displays will be dismantled by the time specified by the Scientific Display Committee and Displayer is responsible for the removal of their display.
  7. Displays that are not dismantled/removed from display hall by the specified time will be disposed of.

## VI. Display Hours

1. Scientific Displays will be open for viewing beginning on the first day of the Annual Meeting. **Judging will be complete by day two at lunch time and the display is to be dismantled by the end of the President banquet on day two.**

## VII. Liability

1. The displayer shall assume all responsibility for their display. **The MSRT is not responsible for any loss or damage.** Every effort will be made to assure the safety of your display.

## VIII. Judging

1. Selection of Judges will be made by the Scientific Display Chairperson. Judges names shall only be known by the Scientific Display Chairperson. The number of judges shall be at least three, but more may be added at the discretion of the Scientific Display Chairperson.
2. Judging criteria shall be based on the following with the total possible being 50 points:
  - a. 0-5 Points will be awarded in each of the following areas:
    - i. Content
      1. Display theme is clearly identified
      2. Content supports Theme
      3. Content is accurate
      4. Sources accurately cited
      5. Subject has value to radiologic science professionals
      6. Originality of work by displayer(s)
    - ii. Display Quality
      1. Display id neat and well-constructed
      2. Material is well organized; format is “eye-catching”
      3. Graphics are of good quality
      4. Spelling and grammar are correct
